HEALTH INSURANCE AS A MARKET PRODUCT

We all know we need life insurance for myriad reasons. We also know we need health insurance for many of the same reasons. Yet many of us do not buy what we need especially when we are young, even if we can afford it. Affordability is certainly an issue, but may not be the only one. Twenty Five percent of the uninsured are eligible for Medicaid or other programs but have failed to sign up!

When we do make the life insurance purchase, the policy is very clear. But health insurance is a whole 'other issue'. You often cannot get a copy of your actual policy. If you ask for

one you might get just a summary brochure. It is almost impossible to find out who accepts the insurance or find out what is covered or when items are excluded, etc. No one would buy life insurance under anything like the circumstances surrounding health insurance.

So why do we not make the purchase? Because it does not seem to be a good buy. Obviously when we are young, the odds of us dying within five years are quite low, so the return on buying life insurance seems poor. The same applies to health care insurance when we are young. We see the high premiums and realize quickly that we would be subsidizing the old and already sick. Thus, it seems like a poor investment of our money.

Calculating the costs of a life insurance policy requires esoteric math, but is relatively straightforward. Calculating the cost of a lifetime of health care is somewhat more problematic as the total cost and timing of the expense is harder to predict. Most health insurance policies have a maximum payout (usually \$1 million) and vary from state to state because insurance is still regulated at the state level.

Solving our health access (i.e. insurance) problem in the United States is an increasing problem as the escalating costs drive more and more people to consider foregoing insurance when

that seems to favor them financially. In addition, health insurance tied to one's job is outdated, as few people will have only one employer over their lifetime. HSAs, HRAs, and the like, have had an interesting impact on this. The use of catastrophic coverage and high deductibles drives its owners to more judicious use of health care and to lead healthier lifestyles. This now represents over 15% of the insured market. But this combined with government-based, taxpayer funded safety net programs may not be enough to solve the problem.

Perhaps a little out-of-the-box thinking could help. Insurance is

regulated by the state insurance commission. But life and health insurance are handled very differently. Perhaps that should change. How about a combined life and lifetime health insurance policy with a guaranteed payout as health related payments and the remainder as a death benefit. This could be set up to be purchased at birth or at the age of majority with guaranteed issue. The indigent would be given a voucher for their premium and it could be fully funded by say age 60. This is just one idea. We need creative ways to solve our current situation. Let me know what you think and what your ideas are for fixing our health care access crisis.

EDITORIALLY SPEAKING

PHYSICIAN, HEAL THYSELF... **ON SECOND THOUGHT, MAYBE NOT**

Ask counsel of him who governs himself well. – Leonardo da Vinci (1452-1519)

Ah Spring! Longer and warmer days, shoots of green grass begging for mower, flowering trees scenting the night air, and leaves sprouting miraculously from longbare branches. We have certainly earned our way to this season after a particularly harsh winter. The beauty of springtime reminds us of why we live in Michigan. The change from winter should encourage even the most dedicated couch potato to get outside and walk, bicycle, swim, run, fish, golf, and work in the garden and yard. Too often, though, our busy schedule interferes with, and takes

precedence over, routine health maintenance habits such as regular exercise. Physicians tend to be better at preaching about healthy habits than practicing them. Taking care of others may lead to neglecting our own needs.

Counseling patients is an important aspect of medical practice. The link between a doctor's personal health habits and the ability to effectively advise patients on four key health issues; tobacco use, maintaining a healthy weight, regular exercise, and alcohol use, is strong. Studies have shown that the more poor health habits a physician has, the less likely he or she will appropriately counsel their patients regarding the abovementioned habits, and vice versa.

Doctors also tend to be reluctant to adopt the role of patient, even when illness strikes. Physician - patients often take a more passive stance when it comes to their own health. A JAMA study in 2003 revealed that physicians tend not to have a primary care doctor themselves. There is, apparently, a problem with accepting and trusting medical advice. One study showed that one-third of physicians did not have a regular source of primary health care, and internists, surgeons, and pathologists made up a significant percentage of those

fatalists. These doctors supposedly feel that they are more than adequately trained to deliver self-care. Interestingly, pediatricians and psychiatrists were the most likely to have a primary care physician.

Among the latest trends in medical school curricula is inclusion of course objectives to educate future physicians in taking care of their own physical and emotional needs as well as their patient's. The assumption that by being your own physician you are in good hands is probably a combination of

egotism and indolence. The importance of having

another's perspective far outweighs any benefit from being one's own second opinion. Our patients will be better served by having physicians who embrace a healthy lifestyle and seek advice from their primary doctor when needed.


JOINT SECTION REVIEW, HOUSE OF DELEGATES UPDATE, OPPORTUNITIES FOR INVOLVEMENT

and political policy which may reshape an entire sector of our economy. You need to be involved in this process and you will be involved in this process.



AMA Foundation Honors Compassionate Physicians With Excellence in Medicine Awards

The Dr. Nathan Davis International Award in Medicine Goes to

DR. APPARAO MUKKAMALA, MD

The Dr. Nathan Davis International Award in Medicine honors a physician for outstanding international service in the areas of medical practice, medical education or medical research. This award for 2009 was given to AppaRao Mukkamala, M.D., from Grand Blanc, Michigan, established NRI Medical College and General Hospital in the state of Andhra Pradesh, India. The medical school has dramatically impacted health care in India by providing a stream of physicians into the country as well as cutting-edge medical research and free care to the community.

Facing adversity is nothing new to AppaRao Mukkamala, MD-and neither is conquering it. As the seventh of 10 children growing up in a three-bedroom home in Andhra Pradesh, India, Dr. Mukkamala never knew the luxuries of running water, paved roads or hardwood floors.

But his humble beginnings didn't stop him from actively pursuing his mission to help others. He often says, "We must do what we can in our own little corner of the world to make this place a better place to live in." So as a teenager, that's what he set out to do, beginning medical school at the age of 16.

Upon graduating at age 23, he moved to the United States with \$1.50 in his pocket, a suitcase full of clothes and his medical degree in hand. More than 30 years later, Dr. Mukkamala, who now resides in Grand Blanc, MI, has made great strides across the globe.

In 2003 he and a group of friends established NRI Medical College and General Hospital in Andhra Pradesh, which today is rated as one of the better schools in India. As president of NRI General Hospital, Dr. Mukkamala runs a 750-bed facility that provides free and low-cost care to 1,000 patients every day.

Following the Asian tsunami of 2003, Dr. Mukkamala and his wife founded Chinmaya Vijaya Orphanage to provide a safe and stable environment-including food, health care and education-for young girls in Andhra Pradesh. The orphanage houses almost 50 girls.

If starting a medical school, hospital and orphanage weren't enough, Dr. Mukkamala founded the Telugu Association of North America, the largest ethnic Indian association in the United States. He was the first physician to serve on the board at Hurley Medical Center, led initiatives to form international medical graduate sections in both the Michigan State Medical Society and the AMA, and is heading a project with colleagues and community leaders in Michigan to open a new medical school.

"Dr. Mukkamala is a born leader and one of the most compassionate and caring individuals that we have ever met," says Peter Levine, executive director of Genesee County Medical Society, of which Dr. Mukkamala once served as president. "Community leaders seek him out, colleagues ask for his advice and students know him to be an enthusiastic supporter and mentor."
