## Health Can't Wait

It is clear from the 2019 House of Delegates, and from discussions that of been held over the last several

years, that prior authorization has become a major impediment to access to care. It has also become a major hassle factor for medical practices, staff, and physicians. It ultimately adds cost to the system, and does not reflect benefit to patients, or even to the payers, and by that, I mean employers, government agencies, etc., who actually pay for the services.

Michigan State Medical Society has implemented a plan which will involve multiple patient and professional advocacy organizations, to combat this situation. The name of the initiative is Health Can't Wait.

We all know stories about delays in care caused by prior authorization. We even know stories of prior authorizations being required for less expensive, more effective drugs than the drug that requires authorization. The stories are so myriad, that they are exhausting. But now it is time for physicians, patients, and others to get together to fight to rationalize this issue.

Please keep your eyes open. MSMS and GCMS will be communicating to engage you in the Health Can't Wait process. There is a Health Can't Wait website https://www.healthcantwait.org/the-coalition. There you will find an opportunity to share your stories regarding prior authorization. Please take

advantage of it to help iron out this process. You will also find in this issue of The Bulletin,

material relating to the Opioid Tool Kit developed for Genesee County. Please use it in your office or in your clinic. It has everything you need when a person with an opioid problem comes into your office. There is also a constantly updated website, https://knowmoregenesee.org/

Finally, this issue again has several pages of material relating to the Flint Registry. We have cards for patients which you can leave in your lobby, that explain what the Flint Registry is and why they should participate. We are trying to get them into offices and other

places where patients may congregate. The purpose of the Flint Registry is to get people signed up who were exposed to Flint water during the crisis. This will allow them to be notified of services when they become available and will allow tracking of outcomes of exposure. The Medical Society has lots of copies. To set a time to stop by and pick some up, please contact Sherry Smith at ssmith@gcms.org or 810-733-9923.



pressure points with legislators, creating a proposal for change and spending months working together to get the legislation passed which would reform the system, to the detriment of the plaintiffs and their attorneys. A lot of the work centered around the process of getting the correct Supreme Court elected to protect those legislative changes. The whole process took a couple of years, and the changes are still in place. We probably have the second most attractive malpractice environment in the county. This has saved physicians millions state-wide and hundreds of thousands



## Flint Water Crisis - Five Years and Counting

FLINT, Mich. – It's hard to believe five years have passed since Flint city officials, under state control, flipped the switch taking our city off Detroit's water system and drawing from the Flint River. I remember driving down Saginaw Street and seeing a lady standing in

the rain, holding a hand-made sign that read, "Don't drink the water!" Looking at her sign, my first thought was, "It's raining hard and she's standing in the rain to make sure this message about the water gets out – powerful." My second thought was, "Why are our leaders not more concerned about the taste, smell, and look of our water." My third thought was, "Thanks lady for the confirmation, regardless of what anyone says, Mayor, City Council, Governor, other City, State, or Federal leaders I am not drinking the water!"

Over the past five years, our city and families have struggled to rediscover life and get back to a place of normalcy. It is a struggle to move beyond the deep hurt pain, and trauma of the water crisis, and truly start the healing and recovery process. From what I've experienced, kids are understandably still very much afraid to drink water out of the faucet. However, I have What is your logo all about? Why is it a bird?

The bird represents the Sankofa bird, a mythical African bird from the Akan tribe in Ghana. The bird is flying forward, yet looking back, and carrying an egg in its mouth. It is symbolic of always needing to move forward, but never forgetting



what happened in the past, and prioritizing the young. The logo suggestion was made by a Flint resident.

also experienced immense pride to be part of a city that is committed to moving forward. Flint is setting a national example of recovery and hope.

As a community, and with the help of local and governmental partners, we quickly joined together to develop systems and processes in a short amount of time to mitigate the impact of the crisis - from help centers, the Flint Registry, expanded Medicaid, teams of partners communicating and strategizing despite differences, the development of a diverse and well-rounded communication team, and so much more. Today, we are

talking and working more closely together than we ever have, we are crossing invisible lines, and setting aside differences for the greater good, our kids, our families, our smallest, and most vulnerable citizens. I would love to see this trend of evidence-based, trauma-informed, and community-driven efforts continue But more importantly, I would love to see all of us, in our many disciplines committed to healing, encourage our friends, neighbors, loved ones, patients take advantage of these recovery-focused resources - especially the Flint Registry.

As professionals, it is important that we believe in the work we do, and at the end of the day, the reason we do what we do is that our work is a part of who we are at the core. Therefore, as social workers, doctors, elected officials, governmental leaders, people are relying on us to carry their voice forward, uphold a duty to protect, serve, and remember to value people as people, not as a number, a diagnosis, nor an object, but as people.

As someone who works, lives, and serves in this community. I have found it necessary to embrace recovery, and welcome the healing process. I must say, after what we've faced, our city, my family, my children,

### Update: Bona Fide Prescriber-Patient Relationship


On January 4, 2019, Rule 338.3161a took effect, which details the bona fide prescriber-patient relationship that is required prior to a physician being able to prescribe a schedule 2 to 5 controlled substance. A bona fide prescriber-patient relationship is defined as follows: (1) a treatment or counseling relationship must be established; (2) the prescriber must have reviewed the patient's medical records; (3) the prescriber must have completed a full assessment of the patient's medical history and current medical condition; and (4) the prescriber must have created a record of the patient's condition, and maintained this record, pursuant to the standard of care.

As always, there are exceptions to the above rule. The following are scenarios in which a prescriber need not have a bona fide prescriber-patient relationship prior to issuing a prescription for a schedule 2 to 5 controlled substance:

- When a prescriber is providing on-call or cross-coverage for another prescriber, who has already established a bona fide prescriber-patient relationship, and the on-call or cross-coverage
  - physician reviews the patient's relevant medical records, medical history, and changes in medical condition. The on-call or cross-coverage physician must then document the encounter in the medical record in accordance with the standard of care.
- When a prescriber who is following or modifying the orders of a prescriber who already has an established bona fide prescriber-patient relationship with a hospital in-patient, hospice patient, or nursing care facility resident. This encounter must be documented in the patient's medical record in accordance with the standard of care.
- When a prescriber who is
   prescribing for a patient that has
   been admitted to anursing home
   facility or hospice care. For the
   exception to apply, the bona fide
   prescriber-patient relationship must
   be completed in compliance with

- the nursing home facility or hospice admitting rules. The prescriber must also document the patient's medical record in accordance with the standard of care.
- When a prescriber who is prescribing for a patient and the requirements to establish a bona fide prescriber-patient relationship are completed by an individual licensed under article 15 of the act. The prescriber must document the patient's medical record in accordance with the standard of care.
- When a prescriber treating a patient in a medical emergency.

Another exception to the requirement of a prescriberpatient relationship is currently being considered and is packaged in two new bills, House Bill 4224 and 4225. Both bills were passed by the House on April 9, 2019. They will now be sent to the Senate for review. The Bills, if passed, would allow physicians to prescribe hospice patients with controlled substances without first requiring



a prescriber-patient relationship. Additionally, a prescriber would not be required to obtain and review Michigan Automated Prescription System (MAPS) prior to prescribing a hospice patient with more than a three-day supply of an opioid or other controlled substance as long as the patient was under hospice care when the medication was prescribed and MAPS was reviewed upon the patient's admission to hospice care. For additional information regarding the progress of these bills, visit the Michigan Legislature's Website for House Bill 4224 and 4225.

Finally, Rule 338.3135 requires the following individuals to complete a one-time opioid and other controlled substances awareness training: licensees applying for or holding a controlled substance license and for delegates who prescribe, administer, or dispense on behalf of the licensee. This requirement takes effect on September 1, 2019 for individuals renewing their controlled substance license, with the first renewal cycle occurring after the promulgation of this rule, and for initial licenses issued after September 1, 2019.



### Meridian Health Plan

GCMS practice managers hosted Meridian Health Plan May 9. Kristen Gasieski, Manager of Network Development, met with the assembled managers.

Peter Levine reviewed the Opioid Tool Kit, which was developed by the Greater Flint Health Coalition, the Medical Society. He also distributed boxes of flyers about the Flint Registry.

Finally, he told practice managers about an MSMS initiative, which is fully supported and engaged in by Genesee County Medical Society and a consortium of other provider and consumer organizations. This is an initiative to rationalize the prior authorization process. (The ensuing meeting supported the need for such an initiative.)

Kristen provided updates on new vendors engaged

by Meridian. For medical oncology and radiation therapy the new vendor is Health Help. Utilization management for radiology and Cardiology is eviCore.

The practice managers expressed serious concerns regarding eviCore. They described. problems with that vendor from their experiences with other insurance companies. They were told that Meridian has a manager whose specific purpose is to serve as a liaison with eviCore. If a problem arises, managers were told to call Utilization Management or Network Development.

Equian will provide inpatient claims reviews for cases exceeding \$50,000.

Several billing issues were described. In some cases, Ms. Gasieski was familiar with the issues,



and some were new. The group discussed several known claims issues. There was a universal concern about money being pulled back for claims that were prior authorized, or after being determined by management to be appropriate for payment.

There is also concern about bundled payments on some of these issues. There was discussion about escalating the communication. Kristen will try to resolve the issues before escalating.

The group discussed several issues that take up massive amounts of physician and staff time, such as the need to manually post. There are also significant concerns about the Customer Care Department. There is also a problem with the denial code 170, which indicates that the provider is deceased. This is been corrected.

In addition, credentialing problems were described. It may take a year to fix those issues.

The June 6 meeting will focus on Health Alliance Plan. The August 1 session will be on Prior Authorization - What is Working and What is Not. On September 5, McLaren Health Plan will be speaking. The October 3 meeting will feature a presentation will be provided entitled, "What's New with MIPS." The managers requested a meeting with Molina Health Plan for November 7.

Bobby Mukkamala, and John Waters, were also in attendance. Dr. Mukkamala served as Chair of the MSMS Board of Directors. Dr. Waters serves as Treasurer of the MSMS House of Delegates.

In elections, Dr. Bobby Mukkamala was elected MSMS President-Elect. Dr. John Waters was elected Treasurer of the Michigan State Medical Society Board. Dr. Nita Kulkarni was elected to the Board of Directors. Dr. Pino Colone was reelected as an AMA Delegate.

Injection Practices for Recreational Drugs, approved as amended; Requiring the Use of Plain Language on Written Consent Forms, approved as amended; Associate Physician Limited License, approved.

Dr. Colone announced his candidacy for MSMS President-Elect. The election will take place at next year's House of Delegates, in Dearborn.

The House of Delegates also paid respects to colleagues who have passed away since the last House meeting. From Genesee County, those individuals included Drs. Louis Coriasso, Rudolf Goetz, Orestus Iung, Marvin Latchana, Berton Mathias, Robert Michels, Rabbi Salimi, and Russell Sandberg.







## Actively Addressing Social Determinants of Health will Help Us Achieve Health Equity

#### Actively Addressing Social Determinants of Health will Help Us Achieve Health Equity

Each April marks National Minority Health Month, providing the opportunity to acknowledge the progress made in reducing disparities, as well as a chance to reflect on what more needs to be done to achieve health equity. Discussions about health equity frequently focus on the important roles that preventive services and care quality have in determining health outcomes. While the care we receive plays an important role, health outcomes may often be driven by the conditions in which we live, learn, work, and play. Individuals with inadequate access to food or stable housing are at greater risk of developing chronic conditions and managing these conditions. They also face increases to health care costs and services that might otherwise be avoidable. These conditions are known as social determinants of health and minority populations tend to be disproportionately affected by them.

Social determinants of health can include housing, transportation, education, social isolation, and more. These factors affect access to care and health care utilization as well as outcomes. As we seek to foster innovation, rethink rural health, find solutions to the opioid epidemic, and continue to put patients first, we need to take into account social determinants of health and recognize their importance.

Addressing the social determinants of health begins with identifying a patient's needs and measuring their impact. Organizations may measure these factors using a number of existing tools that can help in the identification process, including:

- Z codes from in the International Classification of Diseases (ICD-10-CM), which are a group of codes within the ICD-10 (diagnostic) codes that help clinicians capture a patient's socioeconomic and/ or psychosocial needs (Examples of Z-codes in table below),
- Accountable Health Communities (AHC) Health-Related Social Needs Screening Tool, which is used by clinicians participating in the CMS AHC model to identify needs related to social determinants,
- PRAPARE tool (Protocol for Responding to and Assessing Patients' Assets, Risks, and Experiences), developed by the National Association of Community Health Centers for providers to collect the data needed to better understand and act on their patients' social determinants of health, and
- Health Leads Screening Toolkit, which is intended to

be used by clinicians as a comprehensive way to assess patients for adverse social determinants.

#### Examples of Z codes

Z55: Problems related to education and literacy Z56: Problems related to employment and unemployment

Z59: Problems related to housing and economic circumstances Z60: Problems related to social environment

Z57: Occupational exposure to risk factors Z64 Problems related to certain psychosocial circumstances

Z58: Problems related to physical environment

Data collection will help us strengthen our understanding of the relationship between social determinants of health and health care use across diverse populations, allowing us to develop solutions and better connect patients to much needed services. We are beginning this effort in several post-acute care provider settings this year by proposing that some data elements be collected on standardized patient assessment instruments. Some of the data elements are derived from questions from the Accountable Health Communities and PRAPARE tools mentioned above.

In an effort to reduce expenditures and improve health outcomes, CMS is testing the Accountable Health Communities Model, which is the first model to include social determinants of health. The model is based on emerging evidence that shows addressing health-related social needs through enhanced clinical-community links can improve health outcomes and reduce costs. The model also helps to foster innovation to support connections between care, food, and housing for patients in need.

Adequately and appropriately addressing social determinants of health will require the efforts of all stakeholders including beneficiaries, community groups, and health care providers. The CMS Office of Minority Health collaborated with the Health Resources and Services Administration Office of Health Equity on an event focused on social determinants of health. Participants heard from renowned speakers on how social determinants influence health outcomes, such as physical and mental health, and major chronic conditions that are more common among racial and ethnic minority groups.



As a Genesee County provider encountering changes in legislation regarding utilization of the Michigan Automated Prescription System (MAPS), and navigating the substance use treatment system with your patients, the Greater Flint Health Coalition and its Mental Health & Substance Use Task Force offer this referral guide as an introductory resource.

### The First Step: Accessing Substance Use Treatment

- · Guardianship or court papers (if applicable)
- · Special education or other school records (if applicable)
- Drug (quantity, frequency)
- Services needed (detox, inpatient, outpatient)

Fees for services are based on a person's ability to pay; therefore, staff will need to know the household income and number of dependents of the person seeking help. A coverage determination will be made at the time of the screening. Staff will let you know if you can expect to have any cost for your services. No one will be denied services based on their inability to pay.

🔼 If an individual has insurance other than Medicaid, call the insurance plan directly to determine covered services and providers.

#### II. Review of Minutes

Motion: that the minutes of the January 22, 2019, Board of Directors meeting be approved as presented. The motion carried.

#### III. Reports

#### A) Community & Environmental Health

Dr. Natzke reviewed deliberations of the Community & Environmental Health Committee. It included discussion of the issue relating to the PFAS in water systems across the state. The Committee also reviewed several resolutions from MSU-CHM students.

#### B) Finance

1. Budget-to-Actual Report, Period Ending 1/31/19

Pete Levine reviewed the budget to actual report for the period ending 1/31/19. He noted the positive bottom line and pointed out areas where expenditures diverged from projections. He also noted that the loss of rental revenue and the loss of a large group of members has created a cash flow problem.

## Motion: that the budget to actual report for the fiscal year to date on January 31, 2019, be approved as presented. The motion carried.

He also reviewed the membership trend report which shows a gap year to year compared with 2018.

Levine reviewed the NPD list. He noted that that number has fallen dramatically. He has contacted each person on that list, but some still remain. He encouraged the Board to contact those on the list. He asked that each Board member contact those on the list that they know.

Dr. Waters reported that he has been in discussions with Mr. Levine about the cash flow. It is their intent to come back to the Board with a proposal.

It was noted that GCMS should maintain its contracts with the Greater Flint Health Coalition. Staff was complemented for its management and for keeping things going for so long.

#### Motion: that the March meeting of the Board will be to review finances. The motion carried.

#### C) Membership

The Board agreed to call and seek members.

#### D) MSMS Update

Dr. Mukkamala reported that a coalition is being built around the burden of prior authorization he said the early push will be with payers to create change in their processes. Levine reported that the issue has come up at each legislative meeting. It's an issue that physicians are passionate about.

- A. Repeal of Prior Authorization for Medically Assisted Treatment

Approved for submission.

B. Procedures Performed on Minors to Alter Sex of Child Be Considered Child Abuse

Consensus to not send the resolution. It was noted that the American Medical Association is in the process of developing a report on this very issue, and the consensus was that it would be the proper thing to defer to that report, which will have representation from all relevant specialties.

The Board reviewed the resolution relating to banning eye tattoos. It suggested the addition of a whereas which would describe the potential risks of the procedure. Once provided, the resolution is to be submitted on behalf of the Genesee County delegation.

D. Michigan State University College of Human Medicine Student Resolutions

Rachel Santay, a medical student, and Dr. Laura Carravallah presented the six resolutions developed by the College of Human Medicine students

a. Eliminating Need for Print and Store M.A.P.S.

It was the consensus of the Board to not submit this resolution. There was a sense that it would require too much legal analysis to successfully research and revise the resolution before the deadline. The Board specifically complemented the students for the work done on this resolution.

b. Promoting Recycling in Michigan

The Board offered several suggestions for revision. The medical students will revise and return to the GCMS offices by Thursday morning for submission to MSMS on behalf of the Genesee County delegation.

c. Requiring Consent in Sex Education Curriculum

This resolution is to be submitted on behalf of the Genesee County delegation.

d. Requiring the Use of Plain Language in Written Consent Forms

The Board provided several ideas to help the resolution. The students will bring it back revised, to the GCMS offices by Thursday morning for submission on behalf of the Genesee County delegation.

The Board requested that a note be made by staff in the 2020 House of Delegates file that a resolution be created regarding plain language in health insurance policies, similar in design to the resolution requiring the use of plain language in written consent forms submitted to the 2019 House of Delegates.

e. Safe Consumption Sites

The Board provided several ideas to help the resolution. The students will bring it back revised, to the GCMS offices by Thursday morning for submission on behalf of the Genesee County delegation

f. Safe Injection Practices

The consensus of the board was to send this to MSMS as is on behalf of the delegation.

#### F) Legislative Liaison

1. 2/25, New Lawmakers Reception Report

Dr. Blight reported that the New Lawmakers Reception was very well attended. Representatives Sneller, Sheryl Kennedy, and Mr. Chris Flores, District Director for Congressman Kildee were in attendance, along with approximately 20 physicians.

2. 2/4 Legislative Liaison Committee Report

The February 4th meeting was chaired by Dr. Duncan. Representative John Cherry was there along with Representative Tim Sneller. Senator Ken Horton participated by teleconference. Chris Flores from Congressman Kildee's office was also in attendance.

Christin Nohner, Michigan State Medical Society State and Federal Government Relations Director walked through the MSMS legislative priorities for the year. They included problems with the opioid laws passed by the legislature last year. MSMS is supporting the introduction of legislation that would apply rules to how drug formulary managers function. In addition, prior authorization was raised by Committee members as a

Representative Sneller reported on a special committee on auto no fault in the House. Ms. Nohner reported that a major priority of MSMS is to work towards fair and appropriate no-fault legislative action with a focus on fraud, transparency, and appropriate fee schedules.

Mr. Flores reported that Congressman Kildee has been placed on several committees and is still focused on the water issue as well as Social Security, Medicare, and changes to the Accountable Care Act.

#### G) Greater Flint Health Coalition

A. Dr. Waters reported that the Greater Flint Health Coalition is requesting Genesee County Medical Society to review outmigration data broken out by specialty, to publish the data as it has in the past and consider engaging in discussions about the data with groups within the physician community.

Dr. Ishaque provided a SIM update, noting that the data is showing significant decreases in emergency room use in addition satisfaction is being expressed with the Social Determinants of Health referral system and questionnaire.

Dr. Christy reported that the February 7 Town Hall on opioid laws was very well attended and that everyone stayed until 9 o'clock PM.

Dr. Christy proposed three topics for the May 2nd Town Hall. The topics included Social Determinants of Health, Outmigration, and Burn Out. The Board of Directors chose the topic of Social Determinants of Health.

Staff was directed to contact Stacie Saylor at MSMS about which insurance companies pay for the SDOH screening . Levine is to ask about having Stacie as of one of the speakers.

3. Future GCMS Practice Manager's Meetings

Peter Levine reviewed the upcoming practice manager topics which included a session on Social Determinants of Health, led by Traci Kim from Complete Eyecare, and several meetings with insurance companies.

The meeting was called to order at 6:45pm by Ed Christy, MD, President, in Flint Golf Club dining room.

#### **II. Introduction of Guests:**

Dr. Christy introduced M. Susan Schneberger, Senior Project Director of Genesee Children's Health Care Access Program; Traci Kim, Lecturer in Public Health and Health Sciences at University of Michigan Flint, and Administrator of Complete Eye Care; Stacey Saylor, Michigan State Medical Society Reimbursement Ombudsperson; Dr. S. Bobby Mukkamala, MSMS Chair of the Board and Member of the AMA Board of Trustees; Dr. John Waters, Treasurer of the Michigan State Medical Society Board of Directors; and Jim Milanowski, Genesee Health Plan President and CEO.

Dr. Christy invited David Geen of Sovita Credit Union to speak to the attendees about their services.

Janée Rankin, representing the Flint Registry, described the new launch and the fact that it will make patients more able to access services. She invited physicians to suggest the registry to their patients.

The assembled asked questions about available fitness and nutrition programs. The attendees also expressed appreciation for the presentations by the speakers.

Peter Levine made a short statement explaining that the Medical Society has been extremely involved in the State Innovation Model and Children's Health Access Project, because they're bringing resources to the physician community which have never been available before including navigators, fitness health and nutrition services.



## The Legislative Liaison Committee Reviews **MSMS Policy Updates**

The Genesee County Medical Society Legislative Liaison Committee met with Senator Ken Horn, Representatives Tim Sneller and Sheryl Kennedy to provide an overview of the House of Delegates meeting that it ended the day before. The meeting was chaired by Dr. Deborah Duncan.

Peter Levine reviewed the outcomes of the MSMS House of Delegates from a policy perspective. He noted that the key issues discussed included scope of practice, support of expanded maintenance of certification relief, prior authorization problems and solutions, concern about vaccination laws, opposing Medicaid work requirements.

Also discussed was organizational remodeling. GCMS' own, Dr. Bobby Mukkamala, was elected as MSMS President-Elect. Dr. John Waters was reelected to the Treasurer's position on the MSMS Board, Dr. Nita Kulkarni was elected to the MSMS Board.

The Committee discussed other major issues in the legislature. Senator Horn noted that here are off-line discussions about fixing the auto no-fault situation. He predicted passage in the Senate of a reform law before the end of the week. The budget is still a major issue, with \$2.5 billion needed to fix the roads.

Peter Levine distributed Opioid Tool Kits to those assembled and encourage them to tell others about it.

The next scheduled meeting will be held on June 3 and a Special Session on Prior Authorization on August 1, at 8 AM. Please contact ssmith@gcms.org or call 810-733-9923 if you would like to attend either or both meetings.



The Flint Registry is a resource to see how the people of Flint are doing and provide support for those impacted by the water crisis. After completing a survey, individuals are referred to services that promote health and development such as education, health and nutrition programs. Support, especially for children, includes referral to Genesee Health System Neurodevelopment Center of Excellence – a new, nocost child development assessment center.

The Flint Registry is modeled after other public health registries like the World Trade Center Disaster Registry. The Flint Registry is for anyone who was exposed to lead-contaminated water because they worked, lived,


