



BYLAWS CHANGE

YOU CAN ALWAYS GO, DOWNTOWN

Revolutions are born of hope.

Crane Brinton (1898 - 1968)

Lately, it is becoming increasingly difficult to find a prime parking spot in downtown Flint at night, and that is a positive phenomenon. Not too long ago, you could fire off a cannon up Saginaw Street after 5 p.m. and not worry about hitting anyone or anything. But thanks to economic incentives and investors with confidence that downtown can thrive once again despite a tough economic climate, things are looking up downtown. New building, restoration of existing buildings, apartments and lofts, restaurants and art galleries are evidence that Flint is far from a ghost town and

the potential exists for more positive happenings.

At the north end of the downtown center is the former Durant Hotel that stood vacant and derelict for more than 30 years. It has been wonderfully refurbished into apartments that are 80 percent occupied and a banquet center and ballroom that is hosting an active schedule of wedding receptions, parties, and fundraising events. It is worth your while to tour this multi-million dollar restoration of a longtime Flint landmark hotel.

A few blocks south on the west side of the street is the new Rowe Engineering Building with its striking facade. The ultra-contemporary loft apartments have huge windows facing the street that give a unique view of the activity below. Across the street, the Wade Trim Building has loft apartments that are proving very popular. The downtown population is expanding with the addition of student housing in the former Hyatt Regency/Character Inn Hotel and a recently built dormitory on the fast-growing U of M - Flint campus. Of course, a grocery store is essential if a downtown is going to be viable and the attractive Witherbee's Market and Deli offers fresh meat and produce and a deli that delivers.

Restaurants are an important element to an active and vibrant downtown. Old standby watering holes are still going strong such as Churchill's, the Torch Bar, and

the White Horse. These places are as popular as ever for an after-work happy hour or a casual meal. Four new dining establishments on Saginaw have opened in the last eighteen months are energizing the downtown dining experience and are creating a destination for more than just the locals. Blackstones retained the location and the logo of the once thriving clothing store. It has a loud and lively sports bar ambience that offers good food and drink, live music, and seasonal outdoor seating. Wise Guys

Pizza adds great pizza, sandwiches, and salads to the casual dining options while its next-door neighbor, 501 Grill, is a trendy and popular venue for an eclectic mix of entrees, tapas, flat breads, salads, and a nice wine list, along with outdoor seating in season.

The most recent player in the game is Cork On Saginaw, a wine bar and bistro that opened in February with a big splash. Once inside, you might feel you have been instantly translocated to a Chicago or New York eatery. The long white marble bar and wood and mirrored back bar are beautiful. Stark white walls with aubergine upholstered banquettes and couches add to the upscale motif. Small plate entrees expertly prepared by Chef Marjorie Murphy and staff are affordable and delicious. The wine selection is unequaled in the area. One unique feature that is a big hit is the Enomatic wine dispensers that allow purchase of several varieties of red and white wines with use of a prepaid card. Reservations are not accepted but the wait is worth your while.

Downtown Flint could still use more retail options, and a movie theater would be a big draw for other businesses. However, new business activity and restaurants can be the catalyst for growth that ultimately fuels more businesses and growth. Supporting our downtown businesses with your patronage can benefit the entire community.

THAT BYLAWS CHAPTER 2 SECTION 3 ACTIVE MEMBERS - dues Exempt section be amended to read as follows:

A hardship - A member for whom the payment of dues would be a financial hardship by reason of physical disability or illness, or other reason approved by the governing board of the society, may be excused fully or partially from payment of dues, providing that his/her membership dues have been paid to the end of the preceding calendar year.

That the Genesee County Medical Society Bylaws be amended in Chapter 5 section 3 to read as follows: 4% of the active membership shall constitute a quorum.

Chapter 9 - The Board of Directors, Section 4 be amended to read: 33% of the members of the Board of Directors shall constitute a quorum.

That Chapter 7 Duties of Officers Section 4. Treasurer: hall be amended to read: The Treasurer shall give bond to the trust imposed in him/her as fixed by the Board of Directors and shall have the authority to sign checks in the absence of the secretary. He/she shall serve as a member of the GCMS Finance Committee. The rest of section 4 will remain the same.

That Chapter 8. Committees, Section E be amended to read: Finance Committee - There shall be a permanent Finance Committee consisting of four members elected for a term of two years, two members shall be elected each year. A senior member in terms of length of service on the committee shall be the chairman of the committee and report monthly to the Board of Directors. The additional section should read: The Treasure shall also serve as a member of the Finance Committee. The rest remains the same.

Due to the fact that the Michigan State Medical Society and the American Medical Association have switched from Roberts Rules of Order to Sturgis Rules of Order for running their meeting, that the Genesee County Medical Society Bylaws be changed in Chapter 12 "Rules of Order be changed to read: The deliberations of this Society shall be governed by parliamentary usage as contained in Sturgis Rules of Order unless otherwise provided for in these Bylaws".





BUILDING ON ELECTION WINS: MSMS CONTINUES THE FIGHT TO REPAIR & PROTECT TORT REFORMS

In November, MSMS and MDPAC-which is to say physicianshelped to restore a Supreme Court majority that will uphold our tort reform laws. Strength in numbers made the difference. YOU made the difference, as one of the 16,000 members of MSMS.

But that, alone, is not enough when it comes to our tort reform laws.


It's true that having a "rule of law' majority on the high court helps to protect physicians from frivolous lawsuits and keep professional liability rates stable, which help make Michigan a more attractive place to practice medicine.



How will MSMS accomplish this? One way is by working with key legislators, such as Sen. Roger Kahn, MD (R-Saginaw), who now chairs the Senate Appropriations Committee, to introduce key tort reform protection bills this session that will undo the damage and put more protections in place that would ultimately keep physicians in Michigan.

'I'M SORRY': TWO POWERFUL WORDS

Last year, the MSMS House of Delegates passed Res. 51-10A, which asked MSMS to support "physician apology" legislation. MSMS has supported state legislation that will allow physicians to apologize to patients and family members, and express sympathy or compassion for adverse events without such communication being held against them in court. (Currently, many hospital policies prohibit physicians from saying "I'm sorry" because the apology can be held against them in court as an admission of liability.)

Senate Bill 53, introduced by Sen. Jim Marleau (R-Lake Orion), who also happens to chair the Senate Health Policy Committee, aims to minimize costly malpractice lawsuits that many times are brought on by feelings of anger or suspicion that doctors are not being straightforward when an adverse event occurs. By reducing the number of lawsuits, the bill also can help reduce health care costs in our state.

The bill passed out of the Senate and the House Judiciary Committee. At press time, it was awaiting a House floor vote.

WHY YOUR INVOLVEMENT MATTERS

The stakes in Justice Robert Young's critical reelection campaign and Judge Mary Beth Kelly's election campaign last fall couldn't have been greater. Constant court challenges, legislative attacks, and a shift last year to an activist Supreme Court majority all threatened to weaken our tort reforms.

"This victory further demonstrates the importance of physicians being involved in the political process and in strong grassroots organizations. Our collective voice mattered," said MSMS President Daniel B. Michael, MD, PhD, a Wayne County neurosurgeon. "Without your help in electing Judge Kelly and Justice Young, tort reform would have been at the mercy of a new majority on the Court that recently gave us a glimpse at the beginnings of undoing these laws. We dodged a major bullet here and avoided possibly driving physicians out of Michigan at a time when we already face a physician shortage."

Legislators, policymakers, members of the media, and many others pay attention-and respond-to the voice and initiatives of MSMS. Let's keep our voice strong by engaging in advocacy efforts to preserve these crucial laws



ACCESSING PUBLICLY FUNDED BEHAVIORAL HEALTH AND DEVELOPMENTAL DISABILITY SERVICES IN GENESEE COUNTY

Does a person need insurance to receive services through Genesee County Community Mental Health (GCCMH)?

The GCCMH network of mental health and substance use disorder providers may provide specialty services and supports following an eligibility determination by either the GCCMH Access Center or Utilization Management Department, or at the Genesee County Substance Use Access Center (IARC). An eligibility determination, which occurs face-to-face or on the phone, identifies a person's eligibility for publicly-funded services and supports. If it is determined that a person is eligible to receive services, GCCMH will establish an ability to pay based on the individual's income and number of dependents. For a coverage determination, please call the Access Center at (810) 257-3742, or the Genesee County Substance Use Access Center at (810) 235-9555.

GCCMH is mandated to serve:

- Adults with serious mental illness
- Children with serious emotional disturbance
- People with developmental disabilities
- People with substance use disorders

Is an appointment required?

Not for a screening. Call for information about direct referrals (children) or the best times to walk-in for a screening (adults). We are able to provide a face-to-face or telephonic screening for adults Monday through Friday between 8:00 a.m. and 5:00 p.m. Telephonic inquiries about children are handled in the same time frame. Once the individual has selected a provider, intakes are generally scheduled during the work week, and always within 14 days. In urgent cases, call Crisis Services at (810) 257-3740, available 24/7. CALL 911 IMMEDIATELY IF SOMEONE IS IN DANGER OF HURTING HIM/HERSELF OR ANOTHER PERSON. Do not take the time to contact mental health crisis workers first.

What happens in an emergency?

If there is an emergency and an individual needs to be evaluated for psychiatric hospitalization, call Genesee County CMH Crisis Services at (810) 257-3740, toll free (877) 346-3648 or TTY (810) 232-6310. For substance use issues, call the Genesee County Substance Use Access Center (IARC) at (810) 235-9555, toll free at (877) 301-9555, or TTY at (810) 235-9555.

How long does it take to begin receiving services?

If treatment is recommended following the eligibility determination (screening), appointments for service are available within 14 days. If there is an emergency, an assessment and treatment are available immediately.

Where do we go for the screening? What is the intake process?

All non-emergency mental health screenings for adults are conducted at the Genesee County CMH Access Center, 420 W. Fifth Avenue, Flint, or by phone in some cases. Children are referred directly to a provider for assessment following a brief phone call with the parent or legal guardian. For more information, call (810) 257-3742, toll free (877) 346-3648, or TTY (810) 232-6310.

All non-emergency substance use disorder screenings are conducted at the Genesee County Substance Use Access Center (IARC), 1420 W. Court Street, Flint. For more information, call (810) 235-9555, toll free (877) 301-9555, or TTY (810) 235-9555.

SOME POINTS ABOUT CHILDREN'S PUBLICLY FUNDED SERVICES

- Most children requesting specialty services and support are found eligible for services. Those who aren't because they do not meet eligibility criteria as 'seriously emotionally disturbed' are referred to private providers in the community.
- Eligible children are referred directly to the provider of their choice for assessment and treatment following a brief phone registration.
- GCCMH has increased the number of children served in Genesee County 200% since 2003. Approximately 1,200 of the county's most vulnerable children are served each month by GCCMH's network of providers.
- There are no waiting lists for any Medicaid covered service for children or adults.



"I'M SORRY"

Senate Bill No. 53, introduced January 20, 2011, by Senator Jim Marleau (R-Lake Orion), who also chairs the Senate Health Policy Committee, addresses an issue in Michigan which would allow physicians to express regret about a medical outcome to a patient or family of a patient without fear his or her words would be used against the physician at a later time in a professional liability action, if one is commenced.

Michigan is one of only 15 states without extra legal protection for physicians who want to apologize to a patient or family for an untoward event.

The Bill states as follows: THE PEOPLE OF THE STATE OF MICHIGAN ENACT: SEC. 2155.

- (1) A statement, writing, or action that expresses sympathy, compassion, commiseration, or a general sense of benevolence relating to the pain, suffering, or death of an individual and that is made to that individual or to the individual's family is inadmissible as evidence of an admission of liability in an action for medical malpractice.
- (2) This section does not apply to a statement of fault, negligence, or culpable conduct that is part of or made in addition to a statement, writing, or action described in subsection (1).
- (3) As used in this section, "Family" means spouse, parent, grandparent, stepmother, stepfather, child, adopted child, grandchild, brother, sister, half brother, half sister, father-in-law, or mother-in-law.

Enacting Section 1. This amendatory act applies only to civil

actions filed on or after the effective date of this amendatory act.

The belief is a patient or relative who has had expressed to them compassion or sympathy concerning an untoward event, is less likely to file a medical malpractice lawsuit. Further, the protection for the physician is that such statement is inadmissible as evidence of an admission of liability in any subsequent action if the patient or the family wishes to pursue court action.

Importantly, the statement must be in the framework of an expression of sympathy. A physician who makes the statements: "I was at fault," "I blew it," "the hospital should have done more for you or your relative," or other statements encompassing fault or culpability, are not, however, protected by this bill.

Hopefully, the enacting of this bill, even if it does not reduce lawsuits, may be a refreshing approach allowing dialog between the physician, patient or family members without the fear of a subsequent lawsuit based on that statement alone.

This could be a start of a return to the "good old days" when a physician's communication with patients and family members was open and compassionate.
